

### **Representative Experience**

 Defended a Fortune 100 pharmaceutical company against a multi-count complaint alleging, among other claims, retaliation and harassment under the NJLAD and NJCEPA, obtaining obtained summary dismissal of all but one count and settling the matter for a nominal sum.



- Defended a public university in New Jersey against claims that the university violated a faculty member's First
   Amendment rights and breached a contract based upon unique language added to the faculty member's appointment
   letter, successfully striking the First Amendment claim and winning a unanimous jury verdict following a two-week
